Engaged Learning at the University of Notre Dame

The University of Notre Dame has long been committed to providing students with opportunities for community engagement through community-based teaching, research, and service. In 1983, the Center for Social Concerns was founded to provide opportunities for students to combine theological reflection and social analysis with community service. The Center has now grown to include two minors, a graduate certificate, nine faculty, and a faculty institute. Thousands of students have participated in its social concerns seminars and domestic and international programs.

The Center assists faculty members in developing community-based learning and research courses through which students contribute to off-campus organizations while benefiting from the expertise found there. Through these classes, students' sense of civic responsibility is cultivated; the goal is to foster skills needed to create a more just and humane world. The Center also supports faculty scholarship that responds to community issues. The aim of this work is authentic campus-community collaboration toward the attainment of the common good. The Center also conducts research to learn about the effects of its endeavors on students and in communities. This work enables the Center to improve its initiatives, and to contribute to the growing body of knowledge in the field of community-based learning.

The University joined TRUCEN in 2010 and received the 2010 Carnegie Community Engagement designation. In 2012 it established the Community Engagement Coordinating Committee to support and deepen community engagement at Notre Dame.
